Background and Methodology

Patrick E. Gonzales graduated magna cum laude from the University of Baltimore with a degree in political science.

His career in the field of public opinion research began in the mid-1980s as an analyst with *Mason-Dixon Opinion Research*. During this time, Mr. Gonzales helped develop, craft and implement election surveys and exit polls for television and radio in the Baltimore-Washington D.C. metro area.

Patrick Gonzales has polled and analyzed well over a thousand elections in Maryland and across the country since that time. Furthermore, Mr. Gonzales and his associates have conducted numerous market research projects, crafting message development plans and generating strategy blueprints for businesses and organizations throughout the state.

Over his 35 years conducting public opinion polls, Patrick Gonzales has been widely recognized by his peers for his ability to conduct unbiased surveys, and analyze the results in an impartial, evenhanded manner.

Mr. Gonzales frequently appears on radio and television in the Baltimore-D.C. region as a guest commentator.

This poll was conducted by ***Gonzales Research & Media Services*** from April 29th through May 4th, 2019. A total of 826 registered voters in Maryland, who indicated that they are likely to vote in next year's general election, were queried by live telephone interviews, utilizing both landline and cell phone numbers. A cross-section of interviews was conducted throughout the state, reflecting general election voting patterns.

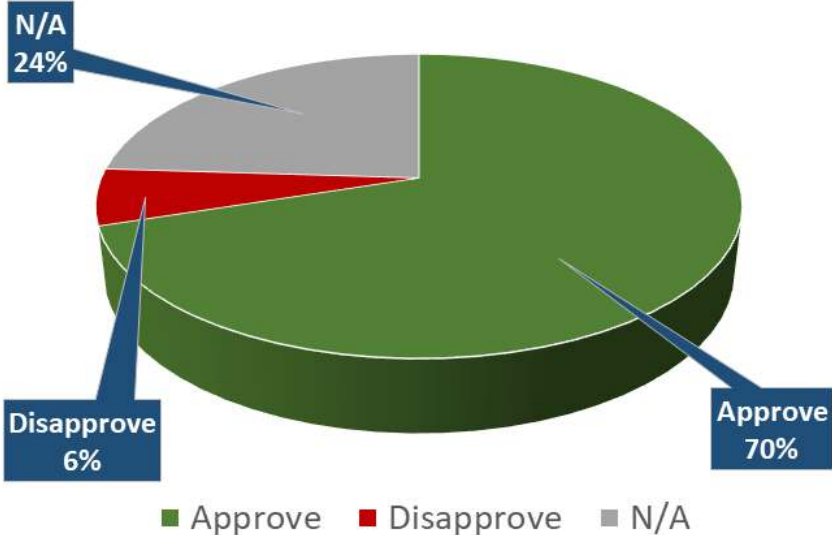
The margin of error (MOE), per accepted statistical standards, is a range of plus or minus 3.5 percentage points. If the entire population was surveyed, there is a 95% probability that the true numbers would fall within this range.

Gonzales Poll Results - May 2019

Peter Franchot Job Approval

Statewide, an impressive 65% of voters approve of the job Peter Franchot is doing as Maryland Comptroller (30% “strongly approve” and 35% “somewhat approve”), while a mere 5% disapprove of the job Franchot is doing (1% “strongly disapprove” and 4% “somewhat disapprove”), with 30% giving no response.

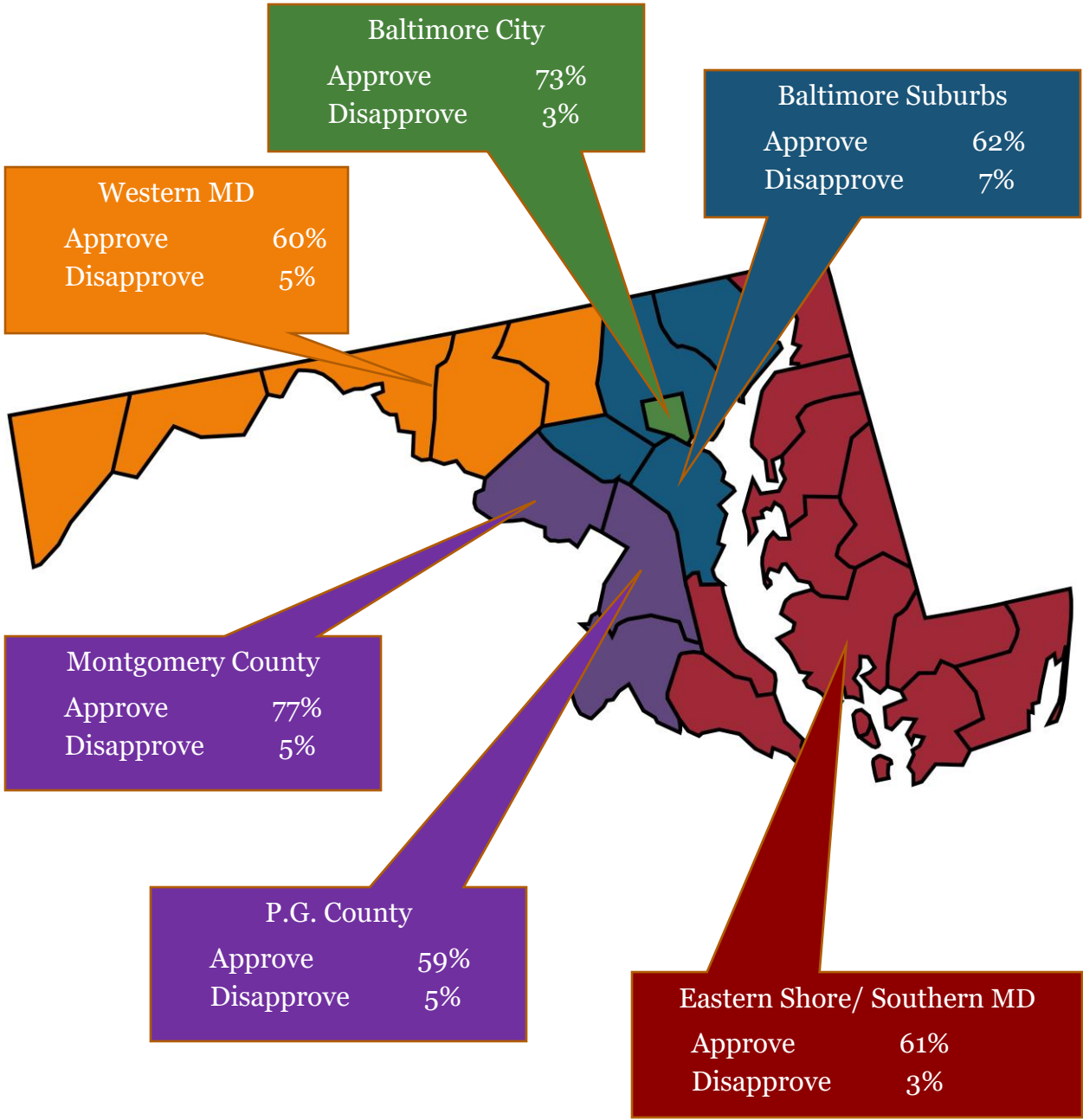
Franchot Job Approval - Democrats

Peter Franchot Name Identification

Statewide, 44% of voters have a favorable opinion of Peter Franchot (19% “very favorable” and 25% “somewhat favorable”), while a mere 4% have an unfavorable opinion (2% “very favorable” and 2% “somewhat favorable”), 26% have a neutral opinion, and 25% don’t recognize the name.

96% of voters with a “very favorable” opinion of Peter Franchot “strongly approve” of the job he’s doing as Comptroller

72% of voters with a “neutral” opinion of Peter Franchot approve of the job he’s doing as Comptroller

Synopsis

The most striking result in this poll of name identification and job approval for Maryland Comptroller Peter Franchot is the near non-existence of negatives for him among voters. Franchot has held statewide elected office for over 12 years - only 5% disapprove of the job he's doing as comptroller and a mere 4% have an unfavorable of him.

Franchot's paucity of negatives helps account for the 1.6 million votes he received in November last year, 150,000 more than the attorney general garnered and 350,000 more than those votes collected by Governor Larry Hogan on election day. Voting "against" an individual can be a powerful force at the ballot box, which is why most politicians are meticulous in trying to not offend (some successful, some not). Based on the findings of this survey, and the November election results, Franchot has done a solid job of establishing a secure relationship with Free State voters.

A notable 65% of voters overall approve of the job Franchot is doing as comptroller...70% of Democrats, 56% of Republicans, and 62% of independent voters.

By race, age, and gender, Franchot's high level of approval is consistent and spread evenly within the subgroups.

In his home county of Montgomery, 77% approve of the job he's doing, while in Baltimore City, 73% approve of the job he is doing as comptroller. In no region of the state is Franchot's job approval below sixty percent.
